President's Column

Getting Back to the Basics of Recycling



As recycling programs have grown and increased in participation with the collection of recyclables from residents throughout the state of Georgia, we have incurred several misnomers. Single stream recycling is a great way to collect recycling. However, we knew that there were always going to be items placed in single stream that are not acceptable for the processors; not that the material isn't recyclable, just not acceptable in single stream residential or even commercial "traditional materials". Our goal as collectors of recyclable items is to educate and enforce to assure the items we do want to collect are what citizens put into bins. Explaining the process to our communities is where the basics must kick in. There is a need to educate the "how and why" of collecting certain items only; i.e., we accept materials based on what the processors are willing to process, and they must be generally clean and dry. They can't sell materials if they're contaminated; some have a very specific end use markets, plus disposal costs are shifting the economics as markets fluctuate. We need to get back to teaching the basics when it comes to recycling. Technology will eventually allow us to recycle more items in the single stream container, but we are not there yet.

The Silver Anniversary of GRC is upon us; let's make this our best recycling year ever! Participate in the Measure Georgia data collection program; submit your programs and outstanding employees/volunteers for the Spirit of Green Awards. Make plans to attend the Conference in September. It is going to be exciting.

Spotlight on Programs

A Recycling Success Story in the Making



Buckhead Recycles is Buckhead's own community-wide office recycling program. Our vision is to have every office building in our community participating in one unified recycling program, creating efficiencies in both collection and costs. Livable Buckhead manages the expansion and implementation of the program, and provides hands-on support for every participating building in making sure they have the best program possible. An important piece of this is to educate users about the core principles of proper office recycling, and we offer a range of tools to help the management teams and tenants of each building do this successfully.

- The month of April 2016 marks the first month that the total tonnage of recycling collected from buildings in the Buckhead Recycles program has topped 100 tons.
- This is a result of the expansion of the program, as well as improved recycling at each participating building.
 - Included 5 properties in May of 2015.
 - As of May 2016 there are 16 properties.

The reason for the success of the Buckhead Recycles program has been:

- Increased attention on the performance of each building's recycling program, and a hands-on approach by the Buckhead Recycle team to address each building's unique needs.
- The partnership and cooperation of the management teams at each building.

But we are not done yet. In 2016 we still hope to:

- Expand the program to the rest of the large, Class A office buildings in Buckhead.
- Address contamination, which is the presence of non-recyclable items in the recycling.
 - The stark reality is that not 100% of what is collected through a building's recycling program is diverted from the landfill. There is always some contamination, and sorting it out and landfilling it places a major cost burden on recyclers. This makes recycling more expensive than it needs to be.
 - We are working hard in 2016 to minimize contamination as much as possible, to ensure that we are controlling costs and delivering the best recycling program possible.

GLASS RECYCLING COALITION FORMED



The Glass Packaging Institute (GPI), along with beverage leaders including Diageo and New Belgium Brewing, and the glass processing and recycling industry, have convened a dynamic group of organizations to make glass recycling work in the U.S. The nearly two dozen member organizations announced in May they are joining forces to create the U.S. Glass Recycling Coalition. The coalition's primary goal is to help build a foundation to make glass recycling a successful industry, and an efficient, high-quality and convenient service consumers want and expect. Coalition members will work on bringing best practices to the US glass recycling supply chain to increase the availability of "cullet," the industry term for furnace-ready recycled glass that can become new bottles and jars, as well as fiberglass. Together, the coalition will work to develop strategies to assist municipalities with glass recycling decisions, and establish a network of glass recycling resources and champions.

A GUIDE TO WORKPLACE COMPOSTING



This spring, Keep America Beautiful, Kimberly-Clark Professional, and the US Composting Council (USCC) introduced a free Guide to Workplace Composting to help organizations develop workplace composting programs that support sustainability, waste reduction and zero waste initiatives.

The guide provides step-by-step instructions and resources to help office buildings, manufacturing facilities, hotels, hospitals, universities and other workplaces divert organic matter - such as food scraps, used paper towels, coffee grounds and coffee filters - from landfills through composting. Composting is a landfill-free way of using decomposed organic materials to fertilize and condition soil. Compost also can reduce erosion, improve drought tolerance and help reduce the generation of greenhouse gases.
