2005 Semi-Annual Meeting Addresses Industry Impact

The recycling industry in Georgia is stronger than ever as traditional and non-traditional materials collectors/processors continue to open, expand, and further invest in businesses throughout the state. The industry has a growing economic impact as businesses expand facilities and capabilities, creating more jobs. As always, the industry is integral to conserving the natural resources of the state through processes that save energy, conserve water, contribute to improved air quality, and generally help to sustain the state's eco-system. To keep this industry working at full steam, our challenge is to heighten awareness and participation level of citizens; many have grown complacent while some local programs have faced budget challenges, including loss of grant funding that supported and enhanced them. Further, we need to strengthen relationships between local government collectors, decision makers, and the markets.

So, we all need a boost! Make plans to attend the GRC Semi-Annual Meeting from April 6-8 at beautiful Callaway Gardens, Mountain Creek Inn & Conference Center.

GRC Council Meetings

Our Paper Council, Recycling Program Manager's Council, Georgia Organics Composting Council and Department of Defense (DOD) Partnership will meet to discuss various plans and projects for 2005.

Tour of Interface Flooring Systems

Headquartered in Georgia, Interface is the largest commercial carpet manufacturer in the world with a goal of becoming the world's first environmentally restorative company. ARD 2004 Raises Awareness for 8th Year



Communities across Georgia were engaged in programs, activities, and events surrounding the

8th annual observance of America Recycles Day from October through the end of November 2004. With the theme, It All Comes Back to You, local event planners kicked off university recycling programs, held e-scrap collection days, organized events at 15 metro Atlanta Staples stores, and received proclamations and recognition from local elected officials. In total, 58 events, 98 displays, 53 (and counting) newspaper articles, 461 local PSA's, and over 4800 pledges were the accumulated results of the efforts. Governor Sonny Perdue proclaimed November 15, 2004 as America Recycles Day in Georgia. Thanks to all event planners for their creative ideas and hard work in planning and holding events to reenergize citizens and promote the importance of recycling and buying recycled content products. GEORGIA RECYCLING COALITION BOARD OF DIRECTORS MEETING

December 6, 2004

I. CALL TO ORDER/WELCOME

The Georgia Recycling Coalition Board of Directors met on December 6, 2004 at the Department of Community Affairs' office in Atlanta, Georgia. President Jerry Hawk called the meeting to order at 10:15 a.m. Board members present included Stephanie Busch, Karen Vickers, Suki Janssen, Scott Vitters, Janet Liberman, Craig Swier, Lee Judge, and LuAnn Chambers. Also present were Gloria Hardegree, Executive Director; Marta Turner, 2005 GRC board member; Lynn Cobb, honorary director; Abbey Mullaney and Bonnie Lantz, committee members.

II. PRESIDENT'S REPORT

No report.

III. SECRETARY'S REPORT

Stephanie Busch presented the minutes from the October board meeting. Hearing no additions, deletions, or corrections, President Hawk called for a motion to approve the minutes. LuAnn Chambers made a motion to approve the minutes; Janet Liberman seconded the motion. The motion passed unanimously.

IV. TREASURER'S REPORT

Treasurer LuAnn Chambers presented the monthly summary report for October 2004. The balance as of November 30, 2004 was \$95,047.30. Lynn Cobb made a motion to file the report to audit. Craig Swier seconded the motion. The motion passed unanimously.

V. EXECUTIVE DIRECTOR'S REPORT

Gloria Hardegree passed out copies of her summary report for October - November as well as an updated calendar of events. The majority of her activities focused on America Recycles. Ms. Hardegree also sent letters to members that had not renewed their membership. She also announced that Steve Levetan had broken his leg.

VI. COMMITTEE REPORTS

Education

Ms. Hardegree announced that the committee had selected the 2004 Weyerhaeuser *Excellence in School Recycling* award winners. The awards luncheon for the 2004 recipients will be held at the Georgia Freight Depot on February 3, 2005. Ms. Hardegree mentioned that the school recycling guide has not been printed.

Communications

Lee Judge informed the members that the committee is continuing to work on the PowerPoint presentation designed to inform the general public about the importance of recycling. Based on input from the board, the committee will upload the presentation file to a member-only website so that members will have an opportunity to review the presentation.

Membership

Gloria Hardegree presented the membership report. The current roster, as of November 2004, is 180 members. She also handed out a list of non-renewals and asked board members for their assistance in contacting the members that had not renewed their membership. The membership committee plans to design a new membership brochure in 2005.

Program

Karen Vickers announced that the semi-annual membership meeting is tentatively scheduled for April 7-8, 2005. Ms. Hardegree reviewed the proposal from Callaway Gardens; the room rate for the conference is \$99/night. In order to move forward with planning the conference, Ms. Hardegree asked members to approve the location of the meeting. Janet Liberman made a motion to hold the semi-annual membership meeting at Callaway Gardens; Karen Vickers seconded the motion. The motion passed unanimously. Ms. Hardegree will work with Stephanie Busch to plan the agenda for the semi-annual meeting.

Lynn Cobb mentioned that several members during the annual membership meeting recommended holding regional roundtables to discuss opportunities to increase recycling rates in communities. SP agreed to host these regional meetings at their facilities. Lynn offered DCA's assistance in coordinating the roundtables.

Ms. Hardegree briefed members on the proposal from Sea Palms Resort for the annual membership meeting tentatively scheduled August 14-17, 2005. The proposal listed a room rate of \$89-109/room; the resort also agreed to waive the meeting room rental fees. To expedite planning the conference, Ms. Hardegree asked members for their approval to hold the meeting at Sea Palms. Lynn Cobb made a motion to approve hosting the annual membership meting at Sea Palms; LuAnn Chambers seconded the motion. The motion passed unanimously. Ms. Hardegree also asked members help in obtaining items for the annual auction; Lynn Cobb suggested that members save their unwanted Christmas gifts. Bonnie Lantz agreed to store the items at her facility in Marietta until the auction.

Due to work commitments, Ms. Vickers resigned as chair of the committee.

Special Events

Ms. Hardegree gave a brief summary on the activities held in Georgia for America Recycles. Sixteen Staples stores held America Recycles events at their stores. Due to the success of the event, Staples is planning on expanding the effort regionally. Ms. Hardegree also announced that 4,278 pledges were received from people in Georgia, and 54 events in Georgia were registered on the official America Recycles web page. Ms. Hardegree added that she believed more events were held in Georgia than were registered; Bonnie Lantz recommended that GRC emphasize to local coordinators the importance of registering events. Scott Vitters offered to work with business leaders to coordinate a more visible event in 2005. Marta Turner mentioned that she partnered with her local cable provider to run her PSAs; she suggested GRC consider produce and airing a PSA statewide next year. Several members voiced their concerns about the cost of producing and airing a PSA statewide. Stephanie Busch suggested that GRC approach a college with video production capabilities about the feasibility of producing the PSA as a class project. She added corporations in Georgia might be more willing to sponsor the PSA if they could see the final product. Ms. Hardegree will contact Scott Vitters and Stephanie Busch to further discuss the ideas for America Recycles in 2005.

Nominations

No report.

VII. OLD BUSINESS

Based on Steve Levetan's recommendation at the October board meeting to research companies that offer on-line credit card payment services, Ms. Hardegree reported that she was unable to locate any other companies that offered comparable services to donate.net. Lynn Cobb made a motion to try donate.net for one year and then reassess after a year; Janet Liberman seconded the motion. The motion passed unanimously.

Ms. Hardegree asked members for their recommendation on how to respond to the proposal received from Resource Bag & Tag, a supplier of special event recycling containers interested in partnering with GRC. Suki Janssen recommended creating a link on GRC's website that lists companies that manufacturer or sell recycling containers. LuAnn made a motion to approve GRC adding a link to its website with vendor information; Lee Judge seconded the motion. The motion passed unanimously.

VIII.NEW BUSINESS

Jerry Hawk handed out meeting minutes from the Southeast Regional Recycling Council (SERRC) feasibility meeting held in November in Alabama. Members discussed the benefits of joining SERRC. Karen Vickers made a motion to table the discussion until after the next SERRC meeting; Janet Liberman seconded the motion. The motion passed unanimously. Jerry Hawk will give an update of the next SERRC meeting at the board meeting in January.

IX. ANNOUNCEMENTS

Before adjourning the business meeting, board members held the state prize drawing for the America Recycles event. Hearing no announcements, Lynn Cobb made a motion to adjourn the meeting. Janet Liberman seconded the motion. The motion passed unanimously. Jerry Hawk adjourned the meeting at 12:36 p.m.

INDUSTRY NEWS

RBRC reports 7.7% Recycling Increase

North Americans recycled 7.7 percent more rechargeable batteries last year, according to the industry's latest data. The Rechargeable Battery Recycling Corp. released its 2004 data Feb. 14. The nonprofit group's recycling program collected more than 4.4 million pounds of rechargeable batteries, 7.7 percent more than in 2003. The group's Call2Recycle cell phone collection program has amassed more than 48,000 cell phones since its April '04 launch. "Interest from national retailers, businesses, communities and other recycling programs has increased since 2003," said Ralph Millard, RBRC executive vice president. More than 30,000 retail and community collection locations participate in the RBRC's cell phone and rechargeable battery recycling programs. More than 400 portable rechargeable battery and product manufacturers and marketers fund the RBRC.

RBRC & Office Depot Partner for Recycling

Office Depot is partnering with the Rechargeable Battery Recycling Corp., a nonprofit, public service organization dedicated to recycling rechargeable batteries and cell phones to collect used cell phones and rechargeable batteries. All 950 Office Depot locations in the United States and Canada will be part of the program. Office Depot will collect (free of charge) all old cell phones and used rechargeable batteries for recycling, including Nickel Cadmium (Ni-Cd), Nickel Metal Hydride (Ni-MH), Lithium Ion (Li-ion), and Small Sealed Lead (Pb) weighing less than 2 lbs/1 kg. These batteries are also commonly found in other portable office electronics products including cordless phones, laptop computers, PDAs, digital cameras, and portable printers.

Office Depot Publishes Industry's 1st Audited Environmental Report

Office Depot Inc. has published the office product industry's first audited environmental report, presenting both corporate and customer environmental performance. The Delray Beach, FL company released the report Nov. 30, making good on a promise it made last year to create a new level of responsibility, transparency and accountability. Pricewaterhouse-Coopers' Global Forest & Paper and Environmental Systems division verified the information in Office Depot's 2004 Environmental Stewardship Report. The report states that 52 percent of the office paper Office Depot's corporate offices used in 2003 contained recycled content, with an average post-consumer rate of 17.5 percent. About 14 percent of the paper customers purchased contained recycled material, at an average of 4.5 percent post-consumer content. The document further states that Office Depot recovered more than 3.5 million

ink and toner cartridges in 2003, a 168 percent increase over 2002.

NAPCOR Reorganizes

The Board of Directors of the National Association for PET Containers Resources (Charlotte, North Carolina) has reconfigured the management of the organization. NAPCOR helps promote PET container recovery in the U.S. and Canada. The organization is closing its Charlotte office and eliminating its two salaried positions. At the same time, NAPCOR is hiring three contractors. Dennis Sabourin, previously with Wellman (Shrewsbury, New Jersey), will be the group's executive director. Mike Schedler will continue as the organization's technical director. Moore Recycling Associates (Sonoma, California) will perform NAPCOR's administrative functions, such as the maintenance of the website.

FedEx Boosts Recycled Content at Kinko's Stores

FedEx Corp. is increasing the amount of recycled content in the paper that its Kinko's office and print centers use behind the counter the company said Dec. 1. The company will move from 10-percent recycled content paper to 30-percent post-consumer recycled content, raising the company's annual post-consumer content to 26.2 percent. It will use the paper in its full-service machines, those located behind the counter at more than 1,100 of its office and print centers. The move brings the Dallas-based company closer to its goal of using 30-percent post-consumer recycled content for all of its paper and packaging services. FedEx worked with International Paper to make sure the 30-percent recycled content copy paper met its operational, quality and environmental standards.

Novelis, Alcan Spin-Off Relocates in Atlanta

Novelis, a manufacturer of rolled aluminum products that is being spun off by Alcan Inc., announced that it has selected Atlanta as the site of its corporate headquarters. The company's headquarters will be located in the Lenox Building in Buckhead and will provide jobs for about 50 people, Novelis officials said. Novelis was scheduled to begin operating as a corporate entity on Jan. 1. Based on the results of the past 12 months, it will have annual revenues of about \$7 billion a year with 13,500 employees worldwide. The new company will own two facilities that are already in operation in Georgia: a recycling center in Greensboro and a foil sales office in LaGrange. Brian Sturgell, the Novelis CEO, said he picked Atlanta as the corporate headquarters location for three reasons. "Our largest single customer is here in Atlanta, the Atlanta airport with its global reach, and the high quality of life and affordable environment for our employees," Sturgell said at a news conference with Gov. Sonny Perdue.

GRC In the News

P2AD Recognizes GRC as White Ribbon Charter Partner

GRC was recognized last fall as a charter Partner in the P2AD Partnership Program, designed to promote sustainability and foster environmental leadership. As a White Ribbon Partner—including trade associations, community groups and environmental organizations— GRC will promote and support the goals of the Program by providing training, consultation, or other services to Partners. A special wooden plaque presented to GRC was made of recycled pine from a deconstruction project held at Fort Gordon. The Fort Gordon project will be featured at the GRC Semi-Annual Meeting in April at Callaway Gardens.

Spotlight on Programs

RBRC Presents Community Recycling Leadership Awards

On November 15, 2004, The Rechargeable Battery Recycling Corporation (RBRC) announced the recipients of its third annual "Community Recycling Leadership Award." This award recognizes RBRC community program participants for their outstanding efforts in rechargeable battery recycling. Each year, one community program is awarded the National Leadership Award and two programs receive the Regional Leadership Award. Community recycling programs in Sandy Springs, GA and Olmstead, MN were awarded RBRC's Regional Community Recycling Leadership Awards. Keep Sandy Springs North Fulton Beautiful has rapidly increased their collection rate as well as their education and public outreach to the Sandy Springs community. They currently collect rechargeable batteries on a full time basis at their recycling drop off center. Special initiatives include: Cell Phone/Battery Recycling event on America Recycles Day in conjunction with a local Staples store; Fulton Government TV customized PSA; Earth 911, which lists rechargeable batteries on the list of items accepted at their recycling facility; production of a 4x6 cardstock pamphlet that lists rechargeable batteries as an item accepted at their recycling facility; the collection of over 3,500 pounds of rechargeable batteries since joining the program. "The success of the RBRC program depends largely on our community partners spreading the word and making it easy for residents to recycle their rechargeable batteries," said Ralph Millard, Executive Vice President, RBRC.

University of Georgia Launches Recycling Project

The University of Georgia in Athens, GA has launched a pilot project aimed at getting its students to recycle, according to the Red and Black student newspaper. Each Tuesday and Thursday from 8 a.m. until 4 p.m., students in the Russell Hall dormitory can place only recyclable material in the building's trash chutes. On Tuesday, the residents can put only paper products in the chutes, while on Thursday, they can place containers made of plastic, glass, aluminum and steel in the chutes, the paper says. The school hopes to begin similar recycling programs in other dormitories, according to the paper. The Athens-Clarke County Recycling Division held 7 America Recycles Day events to promote the new program, collecting 597 pledges from students promising to recycle more and purchase recycled content products.

EPA issues e-scrap recycling contracts worth \$12 million

In an effort to make it easier for federal agencies to hire an environmentally sound e-scrap reclaimer, the U.S. Environmental Protection Agency (Washington) has entered into agreements with seven processors. The contracts come as the result of a yearlong process to seek proposals from potential small businesses and to evaluate their bids. Three of the winning firms will provide service nationwide and the remainder will serve specific regions. They are:

EBay unveils electronics recycling tools

EBay Inc., which touts itself as the world's online marketplace, unveiled its Rethink electronics reuse and recycling initiative Jan. 6 at the Consumer Electronics Show in Las Vegas. The centerpiece of the effort is a Web site, www.ebay.com/rethink, that shows consumers and businesses how to properly get rid of old electronic equipment. It promotes reuse and recycling, facilitating the selling and donating of working computers by offering tools to aid selling, including a safe data destruction utility. The initiative also provides information on third-party companies that can pick up computer systems and peripherals and sell them on behalf of the owners. Another directory helps businesses find a local asset recovery specialist to handle the disposition of multiple computer systems. Visitors to the site also can donate working computers to the National Cristina Foundation, a nonprofit group that provides used computer equipment to schools, charities and other agencies committed to training people with disabilities, students at risk and the economically disadvantaged. The Rethink Initiative coordinates recycling and reuse efforts by electronics companies including Intel Corp., Apple Computer Inc., Hewlett-Packard Co., IBM Corp. and Ingram Micro Inc., of Santa Ana, Calif., an Internet technology distributor, with other participants, including the U.S. Environmental Protection Agency, the Silicon Valley Toxics Coalition, United Parcel Service of America Inc. and the U.S. Postal Service.

Congressmen Introduce National E-Waste Recycling Bill As reported by Waste Age Wire - Monday, January 31

Washington — U.S. Reps. Mike Thompson, D-Calif., and Louise Slaughter, D-N.Y., have introduced a National Computer Recycling Act, which would direct the U.S. Environmental Protection Agency (EPA) to develop and implement a national electronic waste recycling program. If passed, the bill would order the EPA to create a grant program to encourage individuals, organizations, cities and counties to start e-waste recycling programs. The bill also would require the EPA to conduct a study of e-waste and make recommendations on how to address it Additionally, a \$10 fee on new computers to fund the EPA grant program would be imposed. According to the bill, manufacturers and retailers with existing recycling programs would be exempt.
