



RECOGNIZING ESSENTIAL WORKERS



The week of June 22nd solid waste and recycling workers were recognized for their resilience and hard work in keeping our garbage and recycling moving. Here are a few examples of a robust effort by SWANA Georgia Chapter members to elevate this gratitude.



RECYCLING IS ESSENTIAL to SUPPY CHAIN, but CITIZENS AREN'T MAKING THE CONNECTION



The Carton Council is revealing new research which shows that despite the highly publicized paper shortages, most consumers fail to make the connection between their recycling of paper at home and its value in providing feedstock to help make new paper products. According to a national survey conducted last month, 33% of consumers reported they thought recycling might help with shortages but weren't sure how much. While 18% felt recycling had no impact at all on alleviating shortages, 13% were unsure and had not thought about the connection.

The good news is regardless, residents report they are keeping up their recycling during the pandemic. Almost one-third of consumers (29%) report they have been recycling more during the pandemic and 56% have been recycling the same amount.

Due to the coronavirus pandemic, the Resource Recycling Conference will not be happening as a live event in 2020. RRS Releases MRF FPP Study

RRS proudly announced the release of the Materials Recovery for the Future (MRFF) pilot research report demonstrating proof-of-concept for a scalable solution to recycle flexible plastic packaging (FPP) in single-stream material recovery facilities (MRF).

The pilot, the first of its kind in the U.S., was researched and managed by RRS, and conducted at the J.P. Mascaro & Sons TotalRecycle MRF in Birdsboro, Penn. The FPP recovery system and pilot study were funded through a co-investment between leading members of the flexible packaging recovery value chain that includes manufacturers, brand owners, trade associations, and J.P. Mascaro & Sons.

The report, *Flexible Packaging Recycling in Material Recovery Facilities Pilot*, demonstrates that with adequate optical sorting capacity and peripherals, FPP can be efficiently captured in a large single-stream MRF and processed into a commodity bale, known as rFlex.

FPP includes packaging such as plastic films, wraps, bags, and pouches.

Communities Partner with SC Johnson on Curbside Recycling Programs for Plastic Film



Since winter of 2019, several communities, including the <u>Borough of Bradley</u> <u>Beach, NJ</u>, the <u>Village of Loch Arbour, NJ</u>, and <u>Cando Recycling and</u> <u>Disposal</u> in Point Roberts, WA, have partnered with SC Johnson, an industryleading manufacturer of household consumer brands, on pilot programs that add plastic film to their list of accepted curbside recyclables.

As part of these pilot programs, residents can recycle clean and dry plastic grocery bags, plastic storage bags such as Ziploc® brand bags, dry-cleaning bags, and other flexible plastic film at the curbside. Once collected, the communities deliver the plastic film material to end-market purchasers to create post-consumer recycled resin and post-consumer recycled products. SC Johnson is providing funding for community engagement materials to raise awareness of the programs along with other support. The company aims to develop more partnerships with communities across the country that will help communities reach their Zero Waste goals and enhance the circular economy.
