

# 2023 Conference Charts Path Forward for Recycling

The Georgia Recycling Coalition Conference was a huge success thanks to your support! Here's a quick recap of the conference.

Delivered with the perfect blend of optimism and southern wit, **Keefe Harrison**'s thoughtprovoking keynote kicked off the conference with opportunities to leverage data for success. She shared her insight on how she



sees the recycling world changing and ways to leverage data to drive stronger programs locally. "You can shape the data that shapes how things enter and exit your recycling program."

Harrison sees the SE as a region with strong potential to capture significant tonnage and improve the national recycling rate.

The local program session followed with **UGA's Mason Towe, Keep Carroll Beautiful's Martyna Griffin, Georgia Tech's Malte Weiland, and ECGO's Ryan Walden** highlighting how Georgia's universities and local government programs are expanding their recycling efforts via innovation and technology, including how UGA coordinated zero waste events during the baseball and soccer seasons. Georgia Tech launched a new app to encourage and incentivize students for recycling on campus. KCB shared tips on setting up events, applying for funding, and engaging volunteers, stressed the importance of data collection and how to use it to better plan and advertise the events.

From glass and plastics to food service packaging, Paul Benvenuti, with Hefty ReNew Program, Chris Mahin with Knauf Insulation NA and Abbey Patterson with Resource Recycling Systems/NAIMA shared their latest efforts to increase recovery of materials are continuing to grow & evolve. Christy Sapp with Nexus Circular and Mark Steadman with Call2Recycle shared two diverse perspectives on how challenging, but valuable, materials are being addressed more aggressively as we strive toward a more circular economy. Candace Rutherford, with Brightmark, Scott Chase with AMP Robotics, and Rachel Musetti with Cox Enterprises showcased how technology and vibrant programs are elevating the reach of recycling. In the closing session, speakers shared their tips for bridging the gaps between economy and ecology, unifying disparate audiences, and informing industry of ways that can monetize conservation while improving life for disadvantaged communities. Leonard Robinson, Archdiocese of Atlanta, shared his insight on strategies for changing sustainability messaging to resonate with different sectors. Jon Huls with SEMCO showcased ideas and value of edutainment. Natasha Dyer with SWEEP shared details on SWEEP's certification program.

single-stream recycling, glass, cardboard, cans, plastic bottles, and hard-torecycle plastics as part of the Hefty ReNew program.

# New PET Recycling Company Announces First US Facility in Georgia

revalyu Resources (revalyu), a leading chemical PET recycling company, today announced that it will invest USD 50 million during the initial phase of its strategic expansion in its first facility in the USA. The location for its new plant will be in Statesboro, Georgia where groundbreaking will take place in the first half of 2023 and commissioning of the facility is planned for 2024. The 43-acre Statesboro site will employ approximately 70 people. When the first phase is completed, the plant will be able to recycle and process over 225,000 pounds per day of used PET (polyester) waste into sustainable PET polymers (esters) and rPET chips. In further expansion, the plant will have a capacity of up to 450,000 pounds.

Using a breakthrough chemical recycling technology, revalyu has already recycled over six billion bottles. The cost-effective recycling process extracts impurities efficiently and delivers recycled PET of highest purity. The process uses 91% less energy and 67% less water than conventional polyester processes.

Once converted into high quality recycled PET, revalyu's rPET chips can be used to produce any kind of sustainable PET product. Currently, it is mostly used in the textile industry for applications such as seamless knitting, weaving, denim, automotive, furniture or technical textiles.

"We thank all our US customers, partners, and the Statesboro community for their support, trust, and confidence in us. Expanding our operations to the US is an important milestone for our global expansion strategy. It brings us closer to our target of recycling more than two million pounds of used PET bottles per day by 2026 and contributes to solving the plastic waste problem", said Jan

### EPA Clarifies Food Waste Hierarchy

US EPA's new Food Waste Scale is a long-awaited recognition of the importance of composting inedible food scrap and will bring much needed clarity to this issue. The USCC has been urging EPA to make this change for the past decade.

The new (Food Waste Scale) revisits the food waste hierarchy and changes the framework to

prioritize actions that prevent and divert wasted food from disposal. Tiers of the scale highlight different pathways for preventing or managing wasted food in order from most preferred to least preferred.

#### Foodservice Packaging Reaches Recycling Milestone

Since 2017, Foodservice the Packaging Institute's Community Partnership helped program has expand take-out cup and container recycling opportunities. Over the course of seven years, the program has engaged 24 partners in more than 20 regional areas, impacting over 500 individual communities and over 7

million households. The program facilitates engagement between communities, haulers, material recovery facilities (MRFs) and end markets with the goal of adding a suite of foodservice packaging to curbside recycling and/or composting programs. Learn more
