

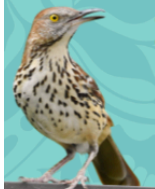

## ReFed Offers Grant Opportunity

Reducing food loss and waste is one of the most powerful levers to cut methane emissions. ReFED's research shows that scaling food recycling and diversion is one of the most immediate, cost-effective strategies to reduce methane today, while tackling loss within beef and dairy systems can unlock major long-term impact.

ReFED's Catalytic Grant Fund is seeking bold solutions and initiatives in two high-impact areas:

Advancing food recycling: Enhancing sorting, decontamination, processing, and access to create more effective and efficient systems.

Reducing methane in the beef and dairy sectors: Cutting loss and waste by lowering animal mortality, improving supply chain efficiency to get more products to market, preventing food waste at the household level, and reducing enteric emissions through climate-smart feed additives derived from waste streams.

### Keep Pickens Beautiful Adds Community Composting

KPB recently added composting bins (pictured above) to the Community Corner near their office. Their in-town Edible Pickens gardens generate a fair volume of compost during the growing season, and they're going to have two food-producing raised beds beginning this spring. Their Teen Squad built the composting bins and skinned them with reclaimed barnwood.

KPB Teens offers weekly community service hours at different locations every Sunday from 2-4pm. They have more than 10 edible gardens that need caring for and need help on other days of the week with trash clean-ups, recycling events, community festivals and lots more. The needs change with the seasons. KPB Teens are notified of opportunities each week and can opt in or out; it's that simple!

## USCC Advocacy Update: USCC 2025 Public Policy Report

The 2025 Public Policy report is now released on the USCC website. This report serves as a concise overview of the 2024-25 legislative cycle. This year's Report focuses on state and federal legislation, policies, and strategies that affected USCC members from summer 2024 through the 2025 legislative season, from Extended Producer Responsibility bills in MD/CO to shifting federal policy on PerFluoroAlkyl Substances (PFAS). The legislative season is formally January through June, when most state legislatures are in session, though previous Q3 and Q4 activity is included.

### USCC Announces Member Connect Initiative

Toward the second half of 2025, the USCC staff leadership saw the need to create real interaction across the country, often challenging to achieve as a national organization. They wanted to provide better support for, and real-time awareness of their chapters and activities, as well as to members in states where chapters don't yet exist. Their Board of Directors liked

this idea and suggested use of existing EPA regions. Since last July, each USCC staff member has been assigned to a region and have been getting to know regional members better through membership renewal calls, reminder calls for surveys, and attendance at meetings. ### USCC Stance on Acceptance of Compostable Products Packaging

USCC's mission is to advance compost manufacturing, compost utilization, and organics recycling. In policy matters, they prioritize the business independence of their compost producer members. USCC values member input and respects/supports that each compost producer must make decisions that best fit their operation, markets, and communities. For this reason, USCC remains neutral—or “feedstock-agnostic” — regarding the materials accepted and systems used to process them into valuable compost. The USCC is continuing this approach regarding the acceptance and processing of certified compostable packaging and products.

For those who are considering including certified compostable packaging materials for processing, the USCC produced the Compost Manufacturers' Decision Making Guide to Accepting or Rejecting Compostable Products. [Learn more and download the Guide.](#)
